With reference to the above captioned subject, we wish to inform you that the Board of Directors in its meeting held on Friday i.e., 06-09-2019 commenced on 04:30 P.M and Concluded at 06:00 P.M have inter-alia approved the following businesses:

1. <u>RECOMMENDATION OF FINAL DIVIDEND FOR THE FINANCIAL YEAR</u> 2018-19:

Promoters and Promoter group of the Company have given their consent in writing for unconditional waiver of their right to receive their dividend. However, there are no provisions for the same in the Articles of Association Company with respect to the waiver off right for receiving dividend.

The Board has accepted the request of the Promoters and Promoter group and the Board has decided to alter Articles of Association of the Company to give right to waive off dividend in the next Board Meeting to be held at a later date.

The Board has also considered that Company will declare Interim Dividend on the basis of Half Yearly results of the Company to be announced in month of October, 2019 instead.

- (iv) Record Date for determining the Names of Shareholders for E-Voting at the AGM will be Friday, September 20, 2019.
